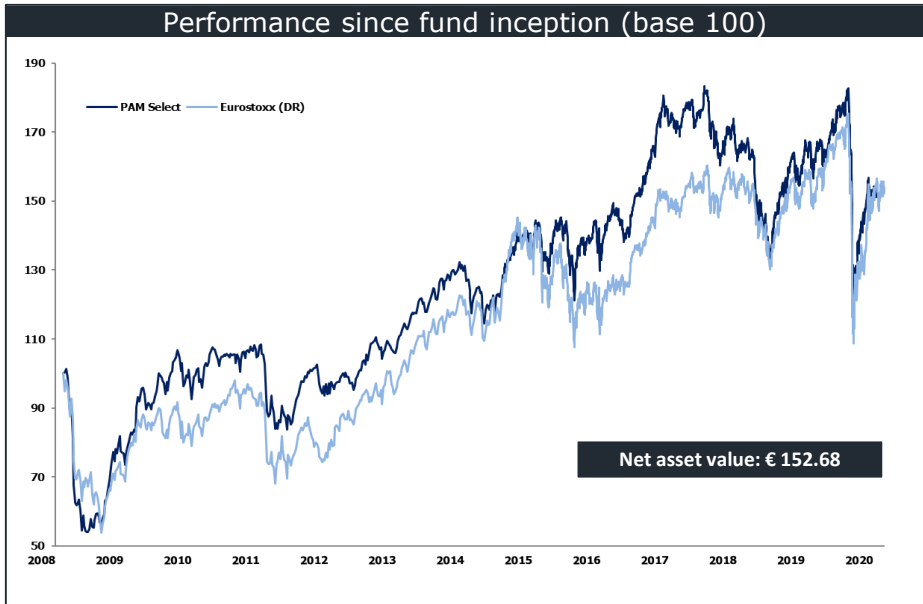


Pléiade AM is an independent asset manager specialised in mutual funds, with a "stock picking" approach.

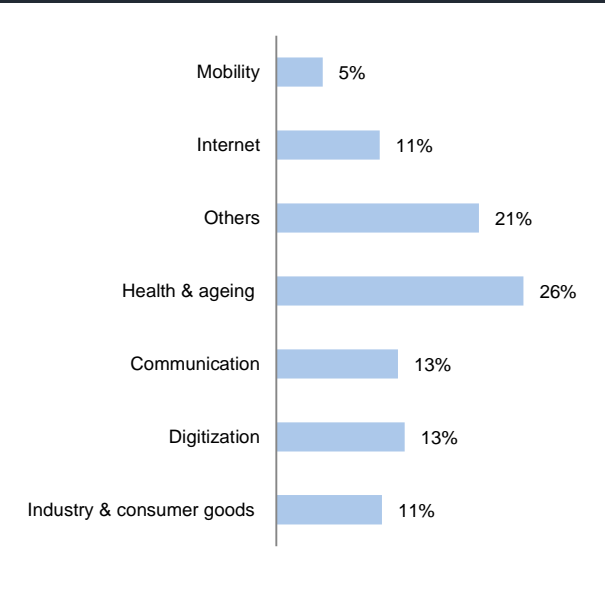

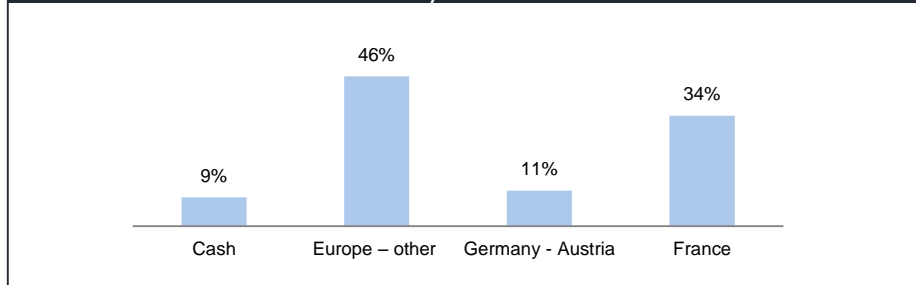

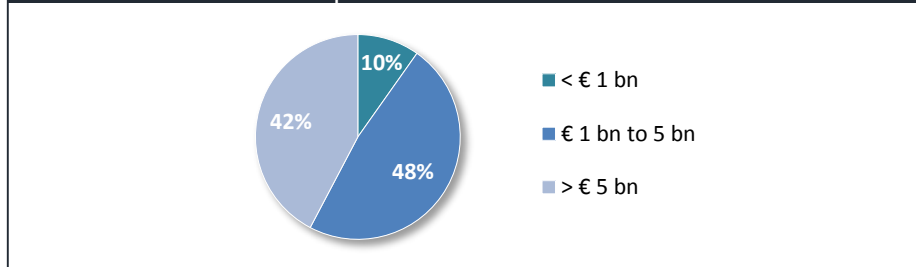
Thematic breakdown
